Dear Respective Government Agencies,

Please be advised **that Santa Clara County, California Superior Court Judge Socrates Manoukian** and his wife, **Justice Patricia Bamattre-Manoukian** (Sixth District Court of Appeals) have many real estate holdings throughout the State of California (and possibly Nevada) from free bank mortgages. The Jurisdiction of California's Sixth District Court of appeals encompasses the following California Counties:

- Monterey County
- San Benito County
- Santa Clara County
- Santa Cruz County

The rates of these loans & aggregate amounts are not available to the general public and not consistent with federal guidelines and the properties owned by these two judges are not accurately reflected on their annual “700 forms – See attachments” ( *Please review 700 forms and real estate holdings possessed by Manoukian Family from 2003-Present* ) – My understanding is that the regulatory agencies responsible for overseeing these issues are the Fair Political Practices Commission and Inspector General of U.S. Department of Housing and Urban Development.

Many of these properties are listed under: “Manoukian Family Trust” and “Bamattre Family Trust” This therefore appears to be Bribery by Banking and Real Estate Industry. (An audit of his judicial record will demonstrate a pattern of biased court decisions which he rules in favor of banking industry in regards to real estate foreclosures.)

The Manoukian’s also have a family member employed with California’s Third District Court of Appeals, The Jurisdiction of California’s Third District Court of Appeals which encompasses the following California Counties:

Santa Clara County Deputy County Counsel, [Larry Kubo](#) is under the supervision of Santa Clara County Counsel: [Orry Korb](#) (California State Bar ID: 114399 )

A whistleblower complaint was filed against Larry Kubo with Santa Clara County Counsel in respect to improprieties in case 1-12-CV226958 involving evidence that was suppressed in regards to suppression of evidence regarding City of San Jose code enforcement complaint filed on June 4<sup>th</sup>, 2014. County Policy Mandates that if the subject of complaint is a county counsel attorney, then the whistle blower complaint must be handled by the Santa Clara County Executive's Office. Santa Clara County violated this policy by rejecting this valid complaint, and instead of following through pursuant to his legal obligation to properly supervise Mr. Kubo pursuant to CRPC 3-110, he violated County Board Policy 3.8 (*and Rule 3-210*) by dispatching Santa Clara County Sheriff Detective David Carroll to fabricate evidence to create an additional fraudulent court record: **CASE: C1493022**. This Fraudulent Court Record was created with the help of Judges David Cena & Rodney Jay Stafford and the Santa Clara County District Attorney's Office and Deputy Public Defender: Jeffrey Dunn (SBN: 209548) . Judge Lori Pegg also was involved in the handling of C1493022 in possible violation of California Code of Civil Procedure 170, as she was formally acting county counsel, originally responsible for the mishandling of whistleblower complaint, by violating the policy mandating it be handled by County Executive (See also CRPC 3-110). In an act of witness dissuasion, a Fraudulent CR-161 CLETS Restraining Order was issued by Judge David Cena and Assistant DA Alex Adam to prevent publishing the name of the Assistant DA in charge of the malicious prosecution in case C1493022. His state bar ID 203869.
